

BY-LAW NUMBER 2010-113

THE CORPORATION OF THE TOWNSHIP OF RIDEAU LAKES

BEING a By-Law to establish a Planning Advisory Committee for the Township of Rideau Lakes.

WHEREAS the Planning ACT R.S.O. 1990, Chapter P.13, as amended, Section 8 provides that the Council of a Municipality may appoint a Planning Advisory Committee composed of such persons as the Council may determine.

NOW THEREFORE the Council of The Corporation of the Township of Rideau Lakes enacts as follows:

- 1) That a Planning Advisory Committee be established for the Township of Rideau Rideau Lakes.
- 2) That the Planning Advisory Committee shall be composed of five (5) Members of Council, one from each of the Wards of South Elmsley, Bastard & South Burgess, South Crosby, North Crosby and Newboro. These Members shall be appointed by Resolution of Council.
- 3) The Members of the Committee shall hold office until their successors are appointed and are eligible for re-appointment.
- 4) Where a Member ceases to be a Member before the expiration of his/her term, Council shall appoint another eligible person for the unexpired portion of the term.
- 5) Three Members shall constitute a quorum.
- 6) Township of Rideau Lakes Planning staff person shall serve as the secretary, and shall keep on file minutes and records of all applications. The secretary shall prepare for presentation to Council, for their consideration, all recommendations from the Committee Meetings.
- 7) The Committee shall comply with such rules of procedures as are prescribed, in addition to complying with the requirements of the Planning Act, R.S.O. 1990, Chapter P.13, as amended.
- 8) The Committee will consider and make recommendations to Council on planning applications, such as consents, plans of subdivision, site plan control, official plan and/or zoning by-law amendments, condominiums, mining operations, etc.
- 9) The Committee will receive and hear delegations concerning planning matters.


- 10) The Committee will receive and hear reports from staff on planning matters.
- 11) The Committee will review and make recommendations to Council on By-Laws to set Regulations, Policies and fees for planning.
- 12) The Committee will hold Meetings as set out in Schedule "A", attached hereto.
- 13) The Head of the appropriate Department, or appropriate staff person will attend the Planning Advisory Committee Meetings.
- 14) That Schedule "A" to this By-Law may be changed from time to time, as deemed desirable by Resolution of Council.

Any previous By-Laws, Resolutions, Motions or Actions of Council that are in contravention of this By-Law are hereby repealed.




