**PURPOSE:** This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2005-6 as amended. The applicants are proposing to construct an additional 268sqft onto an approved 1588sqft dwelling. No construction has been completed since the 2016 approval of A-19-2016 & SP-25-2016 which permitted the development of the 1588sqft structure. The following variance is requested:

- **Section 5.2.2** – Relief of 4.5m from the required 7.5m rear yard setback to allow for a 3m rear yard setback for the proposed 268sqft addition to the approved 1588sqft dwelling.
