PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2023-50 as amended. The applicants are proposing to construct a 22.3sqm (240sqft) one storey accessory building (shed), through which the lot coverage for the property would be exceeded. The following variances are requested:

- **Section 5.2.2** – Relief of 1% from the permitted maximum 10% lot coverage to allow for an 11% lot coverage for the property.
- **Section 3.3** – Relief of 1.2% from the permitted maximum 10% lot coverage for the portion of the property within 60m of the water, to permit an 11.2% lot coverage for this portion of the property.

This property previously received approval through A-34-2022 to expand the existing non-conforming dwelling and remove a 55.7sqm (600sqft) shed. The expansion and removal of the previous shed maintained the maximum 10% maximum lot coverage requirements.


