**PURPOSE:** This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2005-6 as amended. The applicants are proposing to demolish an existing 102.2sqm 1-storey dwelling and 13.6sqm 1-storey accessory structure (shed) to construct a 277.8sqm 1-storey dwelling (including a 142.7sqm ground floor, 111.3sqm basement, and a 23.8sqm screened in porch) with an attached, uncovered 46.1sqm balcony. The following variances are requested:

- **Sections 5.2.2 & 11.1.2** – Relief of 3m from the required minimum 6m south interior side yard setback to allow for 3m south interior side yard setback for the proposed dwelling.
- **Sections 5.2.2 & 11.1.2** – Relief of 0.4m from the required minimum 6m north interior side yard setback to allow for 5.6m north interior side yard setback for the proposed dwelling.
- **Section 3.23** - Relief of 3m from the required minimum 6m edge of private right of way setback to allow for 3m edge of private right of way setback for the proposed dwelling.


