PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting a permission to expand a non-conforming use & minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2005-6 as amended. The applicants are proposing to expand the existing non-conforming 792sqft 1-storey dwelling by adding a basement which would increase the gross floor area to a 1584sqft 1-storey dwelling with basement. The dwelling will remain non-conforming at 9.44m from the high water mark. The application also requests variances from the Floor Space Index provisions as these performance standards were previously conforming to the Zoning By-law:

- Section 5.2.2 Relief of 0.8% from the 15% maximum Floor Space Index to allow for a 15.8% Floor Space Index.
- Section 3.28 Relief of 0.8% from the 15% maximum Floor Space Index within 60m of the high water mark to allow for a 15.8% Floor Space Index within 60m of the high water mark.

TAKE NOTICE THAT this property is also subject to a Site Plan Control Application (SP-24-2021) under the authority of Section 41 of the Planning Act where the applicants are proposing to undertake the works as described above as well as the demolition of the existing 541sqft deck to replace with a complying 360sqft deck and demolition of a 120sqft accessory structure (shed).
