**PURPOSE:** This is an application under Section 45 of the Ontario Planning Act requesting permission to expand a non-conforming use. The applicant is proposing to expand the existing non-conforming 119.1sqm (1282sqft) 1-storey dwelling though the construction of a 27.8sqm (300sqft) second storey addition. The existing dwelling is non-conforming with the permitted uses of the Institutional zone as this zone does not permit a single dwelling as a primary use. The existing dwelling and proposed second storey addition are also non-conforming with the 10m interior side yard setback at a setback of 3.1m for the existing dwelling and 4.7m for the proposed addition.
