PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2023-50 as amended. The applicants are proposing to demolish an existing 30.3sqm (326sqft) covered deck on the waterside of the dwelling, and construct a new 44.9sqm (483sqft) attached uncovered deck on the waterside of the dwelling. The applicants are also proposing to construct a new 35.7sqm (384sqft) 1 storey garage on the property. The following variances are requested:

- **Section 3.22.1** Relief of 11.5m from the required minimum 30m Natural Heritage A setback to allow for 18.5m Natural Heritage A setback for the proposed deck.
- **Section 3.1.8.3** Relief of 1.8m from the required minimum 3m side yard setback to allow for 1.2m side yard setback for the proposed accessory structure (garage).
