PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes’ Zoning By-law #2005-6 as amended. The applicants are proposing to demolish three existing dwellings: a 64.4sqm (693.0sqft) 1-storey dwelling with a 5.3sqm (57.0sqft) attached uncovered deck, a 55.7sqm (600.0sqft) 1-storey dwelling with a 4.7sqm (50.0sqft) attached uncovered deck, a 55.7sqm (600.0sqft) 1-storey dwelling with a 4.7sqm (50.0sqft) attached uncovered deck. The applicants are proposing to construct a 161.5sqm (1738.0sqft) 2-storey dwelling (footprint of 132.5sqm [1426.0sqft] with a 29sqm [312sqft] second storey), as well as a 60.8sqm (654sqft) 2-storey accessory structure (garage) (footprint of 35.7sqm [384.0sqft] with a 25.1sqm [270sqft] second storey). The following variances are requested:

- **Section 3.26.2** – Relief of 14.0m from the required minimum 30m water setback to allow for 16.0m water setback for the proposed dwelling.
- **Section 3.26.2** – Relief of 7.0m from the required minimum 30m water setback to allow for 23.0m water setback for the proposed accessory structure (garage).

TAKE NOTICE THAT an application under the above file number will be heard by the Committee of Adjustment on the date, and at the time and place shown below, under the authority of Section 45 of the Planning Act.

TAKE NOTICE THAT this property is also subject to a Site Plan Control Application (SP-59-2022) under the authority of Section 41 of the Planning Act where the applicants are proposing to undertake the works as described above as well as demolish a 10.4sqm (112.0sqft) 1-storey accessory structure (shed).


