PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2005-6 as amended. The applicants are proposing to demolish an existing 114.7sqm (1235sqft) 1-storey dwelling, as well as a 8.0sqm (86sqft) 1-storey accessory structure (shed) and 10.3sqm (111sqft) unattached deck. The proposal is to construct a 116.1sqm (1250sqft) 1.5-storey dwelling with a gross floor area of 148.7sqm (1601sqft) and 65.0sqm (700sqft) of attached uncovered decking. The existing dwelling is located 10.2m from the high-water mark and 0.9m from the interior side lot line. The new dwelling is to be located 11.3m from the high-water mark and 1.0m from the interior side lot line. The applicants are also proposing to replace the existing septic system. The following variances are requested:

- **Section 3.26.2** Relief of 18.7m from the required minimum 30m water setback to allow for 11.3m water setback for the proposed dwelling.
- **Section 5.2.2** Relief of 5.0m from the required minimum 6m interior side yard setback to allow for 1.0m interior side yard setback for the proposed dwelling.
