PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting a permission to expand a non-conforming use. **The amendment relates to the size of the addition, which was originally noticed as 96sqft, however it is now proposed to be 132sqft. The date of the meeting has also been changed to March 10th, 2021. The applicants are proposing a 132sqft second storey addition to an existing 2780sqft dwelling within 30m of the high water mark. In addition to the 2780sqft dwelling, the property currently contains a second dwelling, 3 sleeping cabins and an accessory structure (carport).**
