PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting permission to expand a non-conforming use. The applicants are proposing to expand an existing 1.5 storey 92sqm (986sqft) dwelling through a 52sqm (560sqft) 2 storey addition. The applicants are proposing to remove a 22sqm (240sqft) partial storey on the existing dwelling, and a 11sqm (121sqft) main floor portion of the existing dwelling.
