PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2005-6 as amended. The applicant is proposing to demolish an existing 112.4sqm 1-storey dwelling to construct a 501.2sqm 1-storey dwelling (including basement, garage, and sunroom) with 30.3sqm of attached, uncovered decking. The following variances are requested:

- Section 5.2.2 Relief of 2% from the required 10% maximum lot coverage to allow for a 12% lot coverage.
- Section 3.28 Relief of 3% from the required 10% maximum lot coverage within 60m of the high water mark to allow for a 13% lot coverage within 60m of the high water mark.

TAKE NOTICE THAT this property is also subject to a Site Plan Control Application (SP-64-2021) under the authority of Section 41 of the Planning Act where the applicants are proposing to undertake the works as described above, as well as install a new septic system.
