NOTICE OF PUBLIC MEETING CONCERNING
PROPOSED ZONING BY-LAW AMENDMENT (ZBA-13-2025)**

TAKE NOTICE that the Planning Advisory & Committee of Adjustment of the Council of the Corporation of the Township of Rideau Lakes will hold a public meeting on the **18th day of February, 2026, at 1:00pm** to review an application to amend the Township of Rideau Lakes' Zoning By-law #2023-50.

The request is to change the zoning classification on a portion of the subject property from Waterfront Residential (RW) to Waterfront Residential Special Exception (RW-X) to permit three dwellings on the lot where only one is permitted. The property is currently developed with two dwellings which are non-conforming as only one is permitted. These two dwellings are both one storey and are 70.6sqm (760sqft) and 62.2sqm (670sqft) in size. The existing dwelling (62.2sqm) is proposed to be relocated on the property, and a new dwelling constructed in its current location. The new dwelling is proposed to be 92.4sqm (995sqft) in footprint (gross area including second floor is 184.9sqm (1990sqft)) with an attached 45.5sqm (489sqft) uncovered deck. The new dwelling constructed is to be located 3m from the east side lot line with an attached uncovered deck located 1.5m from the east side lot line, where a minimum of 6m for the dwelling and 3m for the deck are required. The current dwelling (to be relocated) in this location is currently closer to the lot line than the proposed new dwelling at approximately 2m. This property is also subject to a Site Plan Control application SP-35-2025 to undertake the works as described.

The proposed Zoning By-law Amendment public meeting required under Section 34 of the Planning Act will take place at the Township's municipal offices at **1439 County Rd 8, Delta, Ontario, K0E 1G0**.

TAKE NOTICE that the Township of Rideau Lakes has determined this application to be complete under Section 34 (10.7) of the Planning Act.

ANY PERSON may attend the public meeting(s) and/or make written or verbal representation either in support of or in opposition to the proposed amendments.

If a person or public body would otherwise have an ability to appeal the decision of the Township of Rideau Lakes to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

PUBLIC HEARING – You are entitled to participate in the public hearing on your own or you may be represented by counsel or an agent to give evidence about this application. Written submissions that relate to an application shall be accepted by the Secretary-Treasurer before the hearing of the application and shall be made available electronically to any interested person for inspection the day of the hearing by contacting the Secretary-Treasurer during regular office hours.
