TAKE NOTICE that the Planning Advisory & Committee of Adjustment of the Council of the Corporation of the Township of Rideau Lakes will hold a public meeting on the **23rd day of April, 2025, at 1:00pm** to review an application to amend the Township of Rideau Lakes' Zoning By-law #2023-50.

This is related to a draft approved consent application B-152-23 which is creating a 0.8ha lot from a 1.6ha parcel. The request is to change the zoning classification on a portion of the subject property from Environment Protection - B (EP-B) to Environmental Protection – B Special Exception (EP-B-X) to permit a single dwelling use only, and to include the performance standards as outlined in the Rural (RU) zone (setbacks, height, lot coverage, etc.). The amendment is proposed as the Environmental Protection – B zone does not permit a single dwelling use and requires a 15m setback to all lot lines. The subject property also contains an area zoned Rural (RU). The request is to change the zoning classification on a portion of the subject property from Rural (RU) to Rural Special Exception (RU-X) to recognize the 51m frontage for the severed lands, where 60m is required.

The proposed Zoning By-law Amendment public meeting required under Section 34 of the Planning Act will take place at the Township's municipal offices at **1439 County Rd 8, Delta, Ontario, K0E 1G0**.

TAKE NOTICE that the Township of Rideau Lakes has determined this application to be complete under Section 34 (10.7) of the Planning Act.

ANY PERSON may attend the public meeting(s) and/or make written or verbal representation either in support of or in opposition to the proposed amendments.

If a person or public body would otherwise have an ability to appeal the decision of the Township of Rideau Lakes to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

PUBLIC HEARING – You are entitled to participate in the public hearing on your own or you may be represented by counsel or an agent to give evidence about this application. Written submissions that relate to an application shall be accepted by the Secretary-Treasurer before the hearing of the application and shall be made available electronically to any interested person for inspection the day of the hearing by contacting the Secretary-Treasurer during regular office hours.
