The request is to change the zoning classification on the subject property from Rural (RU) to Rural Special Exception (RU-X) to permit a development envelope for future residential development (dwelling, well, septic, associated accessory buildings) with a reduced Natural Heritage A setback of 25.5m, and a reduced watercourse setback of 15m, whereas the Zoning By-Law requires 30m setbacks for Natural Heritage A and watercourses.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Corporation of the Township of Rideau Lakes to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Written submissions that relate to an application shall be accepted by the Secretary-Treasurer before the hearing of the application and shall be made available electronically to any interested person for inspection the day of the hearing by contacting the Secretary-Treasurer during regular office hours.
